5. The Sanlam ACA Lifestage Strategy is only available as a default investment strategy to new clients who were previously invested in the ACA Houseview portfolios in their prior fund. The ACA Wealth Creation portfolio's inception date is June 2016. Therefore 5 year returns are a combination of the old portfolio on Sygnia's platform and the current portfolio on AFI's platform.
