2. The Sanlam Unity Umbrella Fund began investing in the Sanlam Monthly Bonus Fund on 1 February 2010.
3. The Sanlam Unity Umbrella Fund previously invested 25% in the Satrix (SWIX) Balanced Tracker Fund and 75% in the Sanlam Monthly Bonus Fund to the end of July 2021.
4. The Sanlam Unity Umbrella Fund began investing in the Sanlam Stable Bonus Fund from 1 August 2021.
5. The Sanlam Unity Umbrella Fund currently invests 100% in the Sanlam Stable Bonus Fund.
6. For the Sanlam Stable Bonus Fund, the bonuses declared are net of guarantee charges. All numbers are quoted gross of investment management fees.
7. Investment returns for periods greater than 12 months are annualised.
